Jack & Jill Late Stage Cancer Foundation was inspired by Jill and Jon Albert's real life story. Jon found himself, his wife, Jill, and their two young children Jake and Jamie facing Jill's Stage IV metastatic breast

cancer. Jill and Jon realized early on in Jill's fight, the disease was not just attacking her body, but it was affecting their entire family. Jill and Jon decided they needed to treat their family along with the cancer.

The Alberts knew that for their kids, strong memories of special times together would be their greatest inheritance. From this notion, JAJF was born. Jill died a week before Thanksgiving 2006.
